- Foal must be identified on or before **JULY 1** if you intend to participate in the futurity as a weanling, yearling or 2 year old.
- **\$50.00** late fee required to accept any foal IDs after July 1 but before July 31.
- **\$300** late fee required to accept any foal IDs after July 1 but postmarked on or before September 1.
\$375.00 thereafter. (\$50 late fee does not include \$25 nomination fee)
- Enclosed **\$25.00** check payable to IPBF to nominate foal for on-going futurities (this fee doubles after July 1) This fee becomes \$300 after July 31st and postmarked no later than September 1st.
- Foals must be registered with APHA as regular or paint-bred to participate in these futurities.
- *Please send photocopy of foal's registration papers.*
- Three-time qualification rule applies to all entries (see General Rules, Section III-D).
- Owner and exhibitor must be current members of IPHC. This is your responsibility to confirm. Enclose a separate check for \$25.00 for each membership payable to IPHC.
- *Please send these papers with your foal if sold. He/She remains eligible as long as all forms and*

- Mare nominations are due with a postmark on or before **December 1st**, the year of stallion purchase.
- **\$100.00** late fee required to accept any mare nominations received with a postmark after December 1st, but before **December 31st**.
- **Mares must be nominated if you intend to participate in this futurity, regardless of possible reclassifications or mare substitutions.**
- Stallion donors must include a check payable to IPBF in the amount of \$175 minimum or ½ the advertised stud fee + \$25, whichever is greater, for each mare nominated (limit 2).
- Information about the futurity will be printed in the IPHC newsletter. To receive your newsletter, include a **SEPARATE CHECK** for \$25 payable to IPHC for membership dues.
- *Please send these papers with your horse if sold. He/She remains eligible as long as all forms and fees are in order.*
