- **\$60** due if paid after **APRIL 1** but before **AUGUST 1**.
- If foal nomination fee was not paid, you may reinstate foal eligibility by paying the following fee schedule: **\$50 LATE FEE + \$30 SUSTAINING FEE PAID ON OR BEFORE APRIL 1; \$75 LATE FEE + \$60 LATE SUSTAINING FEE PAID AFTER APRIL 1 BUT BEFORE AUGUST 1; \$375 FOAL IDENTIFICATION FEE MAY APPLY.**
- Enclose copy of registration papers with entry.
- No entries accepted after **AUGUST 1. NO EXCEPTIONS.**
- Postmark determines date of payment.
- Yearling entries must declare which class, either halter or longeline, on or before **AUGUST 1**. Any entries not declared will automatically be entered into the appropriate sex halter class and will not be allowed to change.
- Three-time qualification rule applies to all entries (see General Rules, section III-D).
- Owner and exhibitor must be current members of IPHC. This is your responsibility to confirm. Enclose a separate check for \$25 for each membership.
