**All weanlings must be checked in and fees paid at the office no later than
6:30am - Saturday, September 17th.**

1. Please check the lists for correctness of your entries. If there are any errors on sex, birth date, ownership, spelling, etc., please contact Carrie Gulling [IMMEDIATELY @ \(515-967-6454\)](mailto:ircgulling@aol.com) or crgulling@aol.com.
2. REMEMBER -weanlings will be split into two or three age divisions on the day of the show. Please do not call us to ask where we think the age-split will be, it will not be decided until we can count the entered foals the day of the show. The age split will be announced shortly before the classes.
ALL WEANLINGS MUST BE CHECKED IN AND PAID IN FULL BY 6:30AM - SATURDAY MORNING.
3. At the time of check-in you will be required to fill out one control sheet per horse. This control sheet will serve the Breeders classes. You will receive your numbers at check in. If you plan to show in the APHA section you will need to purchase a laminated number.
4. Remember -you will be assessed an office fee for your futurity entry.
5. **If exhibiting two yearlings in the long line class, please remember the owner and exhibitor must both quality according to the IPBF rules.**
6. The office will be open at noon on Friday. **If at all possible please check in on Friday evening to avoid the rush.**
7. The stall reservation form on the website explains how to make stall reservations. Also on the website is shows schedule-**PLEASE NOTE ANY CHANGES. NO REFUNDS ON STALLS.**
8. REMEMBER...bedding can be pre-paid with the stall reservation. Sawdust must be paid upon delivery and will be separate from your entries-please bring extra checks. We encourage pre-ordered sawdust as we will have it delivered and secured in your stall prior to your arrival. Please note on the stall form where to pre-order your shavings.
9. ORIGINAL registration papers must be presented at the entry table, and AGAIN when entering the ring to be matched to the horse before showing. **PLEASE HAVE YOUR PAPERS OUT OF ANY PLASTIC SLEEVES; THE WATER STAIN WILL NEED TO BE VERIFIED.**
10. The EXHIBITOR of each entry, UNLESS he or she is the registered owner of said entry or a member of the immediate family (as defined by the APHA RG-160 N.; husband, wife, parent, stepparent, child, stepchild, brother, sister, half-brother, or half-sister), MUST have been an exhibitor in the Iowa Paint Horse Club's shows (EXCLUDING THIS FUTURITY SHOW) a minimum of 3 times during the current year.
11. Owners AND handlers of all IPBF entries MUST be current IPHC members. Adult children of owners must have their OWN membership if they are to be the handlers. Multiple adult, non-spousal owners of an entry must have their OWN membership. Memberships may be paid the day of the show, but BEFORE the class. The IPBF staff will take all possible precautions to advise if a membership is unpaid and a membership list will be provided for you to double-check. **BUT THIS REQUIREMENT IS ULTIMATELY THE RESPONSIBILITY OF THE PARTICIPANTS.** If you have membership questions, you should contact Lindsay McLain 515-491-5111 or lbg81@aol.com

13. If you are entering Non-Pro classes, please have your approved amateur or youth card at time of entry. TEMPORARY AMATEUR OR YOUTH CARDS WILL NOT BE ACCEPTED FOR ANY NON-PRO FUTURITY CLASSES.
