IOWA ALL BREED YEARLING OPEN FUTURITY

ELIGIBILITYREQUIREMENTS:

- 1. Any APHA, AQHA, ApHC, or PHBA registered horse sired by a stallion sold in the 2019 Iowa All Breed Futurity Stallion Service Sale is eligible to compete in the Iowa All Breed Open Futurity (IABOF) classes.
- 2. Owner & Exhibitors of horses entered in the Iowa All Breed Open Futurity MUST be current members of IPHC.
- 3. The IABOF classes will be held concurrently with the Iowa All Breed Futurity classes, but premiums will come out of the IABOF entry fees.
- 4. REFUNDS: No refunds on IABOF classes.
- 5. Substitutions:
 - a. Will be allowed ONLY with a valid vet certificate and eligibility requirements are fulfilled.
 - b. Substitution horse must be owned by the same owner as the horse it is replacing.
- 6. Paid entries may be transferred to new owner if horse is sold.
 - a. A request from original owner must be made to the Futurity committee and document of ownership is required.
 - b. Transfer of IPHC membership is NOT allowed. New owner must purchase their own membership.
- 7. The IOABF classes may be added to or modified at any time with approval of Officers, Board and Futurity Committee.
- 8. All IABOF classes will follow rules and guidelines of the Iowa All Breed Futurity.
- 9. IABOF classes will pay back 100% of entry fees plus any added money appropriated for the current year.
- 10. Checks returned by the bank for non-payment will be assessed an additional charge of \$50 per occurrence.
- 11. The futurity chairman at the show will settle any dispute concerning the rules of the futurity.
- 12. The following documents must accompany each entry:
 - a. Entry form with payment for futurity classes
 - b. Breed registration papers
 - c. Membership form (if applicable)
- 13. All futurity entries must submit an IABOF Entry Form to the Show Secretary.
- 14. Please make all checks payable to: IPHC
- 15. The IABOF will pay back the first 4 places in all classes then one (1) place for each two (2) entries shown, not to exceed payment of 16 places. Ties will not be broken; premiums will be added and split equally.
- 16. Dates and Fees:

Yearlings: July 1st - \$75 August 15th - \$100 Day of Show - \$200
