

IPHC BOARD MINUTES

January 17, 2019

I. Call to order

Lonnie McLain called the meeting to order at 8:00 on January 17, 2019 via a conference call.

II. Roll call

The following persons were present: Lonnie McLain, Carrie Gulling, Justin Britton, Judy Miller, Jerry Cable, Tawny Langenfeld, Cindy Westphal. Guest: Lindsay McLain

III. Secretary Report

- Jerry moved, and Carrie seconded to approve the January 3, 2019 Secretary Report. Motion carried.

IV. Iowa All Breed Futurity Rules

- Reviewed the revised rules. Tawny moved and Judy seconded to approve the rules as revised. Motion carried.

V. 2019 Show Season

- 2019 showbill, classes to add or subtract:
 - Carrie moved and Jerry seconded to add Amateur Performance Halter and Youth Performance Halter along with the corresponding Grand and Reserve classes as well. Motion carried.
 - Should we split HUS to Junior and Senior? After some discussion, no motion was made and the topic was tabled.
 - Should we split Amateur Western Pleasure to Amateur Masters and Amateur Classic Western Pleasure? After discussion, no motion was made and the topic was tabled.
 - Ranch classes – Cindy moved and Carrie seconded to remove all divisions of Ranch Pleasure and all divisions of Ranch Reining and remove the award from the Show Rules. Motion carried.
- Class and stall fees:
 - After discussion, we opted to leave the fees the same.
- NSBA classes:
 - Do we want to offer corresponding NSBA classes at our shows? After much discussion, Carrie moved to add NSBA classes for the core, qualifying classes to April, Memorial Day and the October shows, with 2 NSBA judges per weekend, Tawny seconded. Motion carried.

- There is an NSBA fee of \$3.00 per entry per judge, Carrie moved that we will charge \$10 per class per judge, Tawny seconded. Motion carried.
- Show rules: We will modify the show rules to remove the Ranch Pleasure and Ranch Reining. Any other changes, let Lonnie know.
- Show managers: Jerry suggested that we wait until after the Annual Meeting and the new board is in place.
- Postcards
 - 525 exhibitors and members. 4 postcards per page is 132 postcards at 10¢ = \$26.40 for postcards. \$46.20 for postcard stamps.
 - Carrie moved that we send postcards out, Tawny seconded. Motion carried.
